## STATE BUDGET AGAIN PAYS Down Mpsers Debt

A fter the busiest six-month start to a legislative Session than anyone in town can remember, the Legislature completed budget work on Wednesday, June 28, 2023. Budget bills are now on the way to the Governor, who is expected to sign them.

The School Aid budget once again includes significant funding to pay down MPSERS debt. It also includes a 5% increase to the per-pupil foundation allowance, significant increases to "at-risk" and special education funding, expansion of GSRP, and funding to assist new teachers with student loan repayment.

As in years past, the Fiscal Year 2023 School Aid budget utilized record revenues to continue paying down debt while also making a \$1 billion one-time payment against accrued debt in the system. This was a welcome development and accelerated our timeline for achieving a debt-free system by 2038. The conference report for the Fiscal Year 2024 School Aid budget increases state support for MPSERS costs by \$650 million.

#### The report also includes:

- One-time payments to offset costs for local districts, ISDs, and libraries
- \$215.8 million deposit to fund accelerated reduction of payroll growth assumptions
- \$374 million to hold districts harmless for ongoing cost increases and reducing the system's assumed rate of return to 6% as part of the state's ongoing dedicated gains policy

MARSP thanks Governor Whitmer and state legislators on both sides of the aisle for continuing to make MPSERS debt repayment a priority and for completing the School Aid budget promptly.

The Legislature is largely in recess for the summer, so please take advantage of opportunities to interact with your elected officials when they hold office or coffee hours in your district. Thank them for continuing to support public schools and making MPSERS debt repayment a priority!

## "Thank You" From the Legislative Committee

Governor Whitmer signed Public Act 4, formerly HB 4001, on March 7, 2023. This act amended the 2011 tax placed on retirement income, which ate away at the finances of older Michiganders for over ten years.

"When they file their 2023 state income taxes in 2024, they will see the rate adjustment in the form of less tax owed or a larger refund," said State Treasurer Rachael Eubanks.

Public Act 4 will amend Michigan's current Income Tax Act to provide a substantial tax deduction on retirement benefits. However, the legislation will not take effect immediately. There were insufficient votes in the state legislature for immediate effect, so the law will take effect 90 days after the adjournment of the current legislative session, typically towards the end of the calendar year, and will be phased in over the 2023-2026 tax years.

The Office of Retirement Services (ORS), MARSP, the Department of Treasury, and your tax preparer will provide further information and instruction to help with choices when the phase-in begins in 2024 for the 2023 tax year. MARSP will also continue to monitor Public Act 4's impact on members throughout the phase-in.

During these past twelve years, MARSP has been a warrior against the taxing of pensions and retirement. We have seen many people involved in keeping this issue in front of legislators each year. We want to express our appreciation and gratitude to those people. This was a long-fought battle. Though it was not a perfect ending, it is a positive step for public school retirees.

We want to thank MARSP leadership, who were supportive and encouraging to the Legislative Committee throughout this decade-long fight. Our last two executive directors deserve a special "thank you" for their work alongside MARSP's lobbyist. They logged in many hours of strategizing and debating with those who would be casting their votes.

Also, we have a group of MARSP members, our Legislative Ambassadors, who met with representatives and senators to discuss MARSP's position face-to-face. They are passionate about MARSP's mission and give their time and energy to speak on behalf of members. Thank you to all the Legislative Ambassadors who helped make this issue a priority.

We know there were also many members who made phone calls, sent messages, wrote letters, and met with legislators face-to-face. We want to thank you also for carrying MARSP's message in your own way.

# OUCLUS I JUST HIT MY HEAD ON THE DEBT CEILING!

n January of this year, economists around the world watched closely as the U.S. approached, and then exceeded, the limit on borrowing that had previously been set by Congress. Our elected officials were then required to negotiate a plan to raise or suspend the \$31.4 trillion limit that had been established in 2021, when this problem had last occurred. While those negotiations were taking place, the debt ceiling forced the US Treasury to undertake "extraordinary measures" to insure that the cash kept flowing so that the government could keep paying its bills. Fortunately an agreement to suspend the limit was reached early in June, thus preventing what would have been an unprecedented and destabilizing default on the national debt. Interested parties (including you, me and probably everyone else on the planet) breathed a collective sigh of relief and global financial stability survived, at least for the time being.

The debt ceiling was initially conceived in 1917 as a means of mitigating any blank-check approach to spending that might have developed as the U.S. was dragged into World War I. The idea was to insure that Congress would be involved in spending decisions when expenditures exceeded revenue; certainly a reasonable premise. For most of a century, this mechanism of gaining legislative approval before increasing the nation's debt worked pretty smoothly and the debt ceiling has been raised literally scores of times. But as the scope of government spending has increased, political positions have hardened and legislators have faced more difficult negotiations. The specter of default on the nation's debt has thus taken its own seat at the table. The agreement reached in June will last through December 2024 and will allow the Treasury to borrow money as needed to meet budgetary requirements. Certainly that borrowing will be necessary. In Fiscal 2022, the U.S. budget called for \$6.3 trillion in spending with only \$4.9 trillion in total tax revenue expected. The \$1.4 trillion balance was added to the national debt.

U.S. Government spending is incredibly complicated and much of it is non-discretionary, the result of obligations such as Social Security and Medicare, to name just two such programs; this spending is not optional. During fiscal 2022, nearly two-thirds of government spending (\$4.1 trillion) fell into this large category. Other functions of government, despite being very important, are considered discretionary and must be paid for by what is left over. Given that there isn't much left over, borrowing results. Expenditures for health, education, infrastructure, space, transportation and international affairs are only a few examples. The U.S. has one of the most complex and productive societies on the planet. Keeping it all running will always be expensive.

And that brings us to the bottom line. Some have said that June's agreement to suspend the debt ceiling has done little more than to kick the can down the road, but this fails to recognize the complexity of the problem. Our government is expected to provide countless services both domestically and around the world. Meeting all of these obligations while keeping taxes low is resulting in significant annual deficits; for now, that's just the way it is. Given climate change, the war in Ukraine, tensions with China and the myriad other challenges on the world stage, we can expect to hear more about debt and the debt ceiling. It's a fair bet that our nation's finances will continue to be a fascinating study for decades to come.

As Membership Committe Co-chair and a MARSP School Ambassador, I often have conversations with active school employees about retirement. Through these conversations, I've learned that many active staff are concerned about their future retirement. They wonder what their insurance will look like, if they'll have reduced premiums, or if there will even be a retirement system from which to draw.

At MARSP, we understand their worry. We know from experience that our retirement system is susceptible to budgetary negotiation and corrosive legislation. We also know that, together, we can impact legislators and safeguard our earnings and benefits.

- We did it in 2011 in the face of legislation that sought to defund MPSERS. MARSP's testimony led to maintaining MPSERS and the creation of other retirement options for those hired after July 1, 2012.
- We did it in 2017 when the Legislature considered halting the subsidy for MPSERS health coverage, hiking up your monthly insurance premium.
   When negotiations began, MARSP was the ONLY retirement organization involved and the insurance subsidy remained in tact.
- We did it again this year with the passing of Public Act 4 after a decade-long fight to repeal the 2011 pension tax.

History shows our effectiveness in fortifying the public school retirement system for ALL recipients, current and future. So how do we, as members, invite our working colleagues to join the effort, simultaneously easing their minds about retirement? The key to is to increase MARSP's name recognition and visibility as an advocate for their retirement.

Next time you're subbing or attending a school event, check in on fellow and future MPSERS recipients. Ask questions and use prior knowledge to connect them with MARSP resources. Here's are some possibilities...


#### If they're still working:



## GEORGIA SHARP RECOGNIZED FOR SERVICE TO MARSP

Georgia Sharp (Ionia County Chapter) received the State Distinguished Service Award on March 15, 2023, for her many years of service to MARSP.

Sharp has served on the MARSP Legislative Committee since 2015, and has co-chaired the committee since 2019. She is also the Legislative, Reservations, and History Chair for the Ionia County Chapter.

Her nomination came with the following statement from fellow member Karen Merchant on behalf of the Ionia County Chapter:

"We are very proud of her and her efforts to keep us in lonia County, as well as all MARSP members, informed of what is happening in Lansing. But, perhaps, more importantly is her ability to treat everyone with dignity and respect. She is a kind and loving person and we are so excited to nominate her for this honor."

Sharp stated that her interest in politics began with her parents, who were active at the state and local level all her life. When Sharp retired after 39 years as an English teacher, she found herself with more time to invest in political endeavors. She became chair of her county party, and then served on her county board of commissioners from 2016-2022. "I enjoy meeting and having discussions with legislators and the people that are making the decisions for our government and society," said Sharp.

When she looks back at her service to MARSP, she's particularly proud of the Legislative Committee's efforts surrounding pension repeal. Despite differing
