ABOUT THE FUND

In 1995, the MARSP Foundation Board noticed a void in financial assistance for public school employee professional development. They established the Scholarship Fund in 1995 and awarded the first scholarships the following year. As of 2022, the Foundation had awarded \$116,728.50 to public school professionals.

Scholarships are available to all public school employees, no matter their current positions, so long as they are pursuing career advancement in the public school arena. Eight public school employees from across Michigan received scholarships in 2023 thanks to the generosity of MARSP members like you!

Bruce Moeggenborg retired in 1999 after 41 years as Director of Maintenance Operational Services for Alma Public Schools.

ADAPTING TO THRIVE: MARSP's Continuing Legacy of Innovation and Resilience



President's Message

As I consider my vision for MARSP during my tenure as President, I am drawn to the association's rich history. For over 70 years, MARSP has supported public school retirees through dynamic economic and socio-political climates. At the heart of the association's resilience is its adaptability.

From my first encounter with MARSP to my recent participation in programs and advocacy efforts, I have witnessed MARSP's adaptability and innovation. As MARSP forges ahead, navigating challenges and seizing opportunities, member welfare remains the top priority. Through MARSP, public school retirees like myself find the support to navigate life's daily complexities in an ever-changing world.

A personal journey of support and security

I first learned about MARSP in 2001 in the payroll department at St. Clair County Community College. Dr. R. Ernest Dear, interim President of St. Clair County Community College and then-current President of MARSP, introduced the association during a campus-wide orientation. He emphasized MARSP's mission to safeguard our pensions and healthcare, and his words left a lasting impact. As a perpetual worrier, MARSP offered security about my future retirement. Years later, when unexpected circumstances left me a widow with three young children, I had the reassurance that MARSP was looking out for me.

As retirement approached, I began to feel overwhelmed by the decisions ahead. I attended a retirement seminar offered by the Office of Retirement

Services at Macomb County Community College. I left that meeting with a three-ring binder full of reading material. I knew I had to make several irreversible decisions but there was little to help me determine my best fit. Years later, as a MARSP pension seminar presenter, I could only wish I had found MARSP to assist me in sorting out my choices. MARSP's Retirement Planning Services understands the nuances of the MPERS system and provides tailored guidance to attendees. Through the pension seminars, Michigan's new public school employees and incoming retirees can make informed decisions about their futures.

Membership offers varied opportunities and flexible involvement

I joined MARSP and my local chapter shortly after retiring. While I enjoyed socializing and contributing to local efforts, I appreciated the flexibility to engage as much or as little as I wanted. No matter what, I knew MARSP would keep me informed through their publications and updates, and that my membership would contribute to their influence in Lansing. Volunteers and leaders are always needed, and chapter activities are informative and fulfilling, but MARSP's membership numbers are significant for engaging legislators. Don't believe me? Just look at the recent repeal of the pension tax!

Challenge sparks innovation

Of course, like many associations, the COVID-19 pandemic took a toll on MARSP's membership numbers. During this time, MARSP's forward-thinking leadership, spearheaded by Executive Director Royce Humm, sought alternative revenue streams to increase the value of a MARSP membership. MARSP established the Travel Program in partnership with Collette Travel in 2022.

The Travel Program, now in its third season, has increased MARSP's financial stability and rekindled a sense of community post-pandemic. And I speak from experience! In September 2022, I fulfilled a long-standing dream by joining MARSP's National Parks of America tour. As a single traveler, I can't begin to describe the security I felt traveling with a "school family." I not only met wonderful people and saw incredible natural and man-made wonders, but I also enjoyed the company of other single travelers.

MARSP's adaptability continues in the fight for healthcare funding

Shortly into 2024, MARSP faced a new challenge when the Governor proposed a change in funding for MPSERS healthcare funding (for more on this subject,

see page 12). Since then, I've witnessed firsthand as Royce Humm and MARSP lobbyist Matt Kurta fight for MPSERS funding security. Unfortunately, I sustained a traumatic injury that required surgery just after the Governor introduced the proposal. While in the ER waiting for lab results, I received a MARSP email update and a call for members to voice their concerns to legislators. Even as life thwarts the best-laid plans of MARSP's President, the network of savvy staff, partners, and volunteers continues to get the job done!






Executive Director's Message

Over the last decade, the state has prioritized paying down MPSERS pension and healthcare debt. Through these efforts, MPSERS healthcare is now 126.9% funded according to the Fiscal Year 2023 valuation. As MARSP celebrates this milestone and the role members played in reaching it, concerns arise over the state's continued commitment to MPSERS financial stability.

The Governor's office, the House, and the Senate recently unveiled their budget proposals for Fiscal Year 2024. While all proposals include the usual MPSERS contributions, each redirects an expected \$670 million payment toward MPSERS healthcare debt to other parts of the budget.


The state budget process is long and complex, and MARSP is fighting for the long-term stability of the retirement system every step of the way! We continue working behind the scenes to engage key stakeholders, share our expertise, and ensure the final budget supports today's classrooms without jeopardizing the welfare of tomorrow's public school retirees. We urge you to contact your elected officials during budget negotiations to reinforce our message: **MPSERS healthcare must remain 100% funded!**

Recent reforms prioritize MPSERS financial stability

MPSERS unfunded liability, often called debt, is the difference between what the system holds and what it owes its members. To address this, the state makes annual payments to MPSERS pension and healthcare debt, similar to making mortgage payments on a house. This practice of prefunding became law in 2012 after years of failing to make such payments caused snowballing MPSERS debt.

Additional reforms to the MPSERS Act in 2017 established a minimum funding level for the state's yearly

payment towards MPSERS debt. This ensures that the state's annual contribution remains at least as much as the previous fiscal year when pension or healthcare funding is below 100%.

The state is also statutorily mandated to base its yearly pension and healthcare payments on the valuation from three years earlier. The state budget for 2025 uses data from the 2022 valuation, which put MPSERS healthcare funding at 99.2%. Because it's below the 100% funding floor, the MPSERS Act would need to be changed to use the \$670 million elsewhere in the budget. As mentioned, the 2023 valuation shows healthcare 126.9% funded. So even without a change to the MPSERS Act, additional healthcare funds will become available for the FY 2026 state budget.

MARSP joined others in advocating for the \$670 million to go towards pension debt, which was 68.8% funded as of the 2023 valuation. Ideally, MPSERS pension and healthcare plans would both reach 100% funding before redirecting financial resources. While this outcome is unlikely, MARSP continues fighting to ensure MPSERS healthcare remains permanently 100% funded.

MESSAGE FROM THE OFFICE OF RETIREMENT SERVICES: Insurance eligibility for children extended to age 26

Recent legislation changed the retirement system's insurance eligibility rules for children. Under Public Act 158 of 2023, a child may remain on their parent's insurance until the end of the month they turn 26, regardless of school enrollment. If you want to enroll your child on your insurance, download and complete the Insurance Enrollment/Change Request (R0452C) form.

Using your web browser, navigate to:

2. In the top navigation, choose "Forms and Publications"
3. Scroll to the "For Retirees" section and open [Insurance Enrollment/Change Request \(R0452C\)](#)
4. Complete the form and mail or fax your completed form to:

If the Michigan Office of Retirement Services (ORS) receives your enrollment request and required proofs on, or before, August 31, 2024, coverage will be effective the first of the following month. If ORS receives your enrollment request and required proofs September 1, 2024 or later, coverage will start on the first of the sixth month after receipt. For example, if ORS receives your request and proofs October 26, 2024, coverage will start March 1, 2025.

Your child may remain on your insurance until the end of the month they turn 26. In addition, ORS will no longer require annual student certification (proof that your child is attending school). If you have any questions, visit www.michigan.gov/orsmiaccount. For increased security, you'll use MiLogin to access miAccount. After logging in, you will have secure access to ORS customer service representatives.

New DonorsChoose Fund Supports Classrooms and Builds Relationships

It began with a simple yet powerful idea...

Back in 2000, Charles Best, a high school history teacher in the Bronx, faced a challenge: raising funds for classroom books. As he embarked on this mission, he wondered whether people would be more inclined to donate if they could see the immediate impact of their generosity. To put his theory to the test, Best created a crowdfunding website and called it "DonorsChoose."

Fast forward to the present day, and DonorsChoose has become the premier crowdfunding platform for teachers seeking support for classroom projects. With the support of over 6 million generous individuals, corporations, and foundations, it has facilitated funding for nearly 3 million classroom projects. DonorsChoose vets each project request, ships the funded resources directly to the classroom, and provides thank yous and reporting to donors and school leaders. DonorsChoose also prioritizes projects in low-income and historically underfunded districts, where teachers often bear higher out-of-pocket expenses.

DonorsChoose has earned the trust of educators, district administrators, and donors, including MARSP and the MARSP Foundation. Since 2018, MARSP and the Foundation have jointly contributed \$10,000 per year to DonorsChoose projects in Michigan. Today they're taking the annual contribution a step further. In February 2024, MARSP's Finance Committee began the process of establishing an official DonorsChoose Fund. As of this spring, members can contribute directly to the DonorsChoose Fund, much like the VBDF, Scholarship, or General Fund.

The new DonorsChoose Fund reflects MARSP and the Foundation's dedication to supporting today's public school employees. It complements existing programs such as the Foundation Scholarship Fund, which provides professional development assistance, by investing in day-to-day employee success and career satisfaction.

In 2023, MARSP and the Foundation funded 43 projects via DonorsChoose, with each project underscoring the impact of teacher support on student success.

Here are just 10 of the 43 projects funded:

1. Musical instrument accessories for middle school students
2. "Wiggle" stools for preschool-2nd graders who learn better with the option to move
3. Supplies for a pet chinchilla helping high school students open up and manage stress
4. Cleaning supplies for elementary school cooking class
5. Set-building tools and materials for middle school theater production
6. Picture books to help elementary school students express feelings and solve problems
7. Camera equipment for weekly video announcements by high school students
8. Egg incubator for elementary school students learning about life cycles and native species of Michigan
9. Butterfly habitat, shrimp hatchery, and a grow-your-own-mushroom kit for elementary students learning scientific principles
10. Graphing calculators to help algebra students with ACT/SAT prep

In the years to come, many public school employees will learn about MARSP for the first time through the DonorsChoose Fund. This connection to younger generations ensures the association's continued relevance and longevity. And, after all, MARSP works on their behalf, too, whether they know it yet or not!

1. Log in

Go to www.marsp.org/login-renew or scan the QR code in the left corner. Sign into your member profile.

LOG IN TIP: Your username is your email address. If you aren't sure about your password, select "Forgot Password" below the sign in section. You will receive a link to reset your password via email. Once your password is reset, return to www.marsp.org/login-renew.

2. Select membership type

Once logged in, you can begin renewing your membership. Choose your MARSP state membership. Click "Next" to continue.

3. Choose chapter membership

Select a MARSP chapter membership OR choose "I do not wish to choose a chapter." Click "Next" to continue.

4. Automatic renewal option

You have the option to automatically renew your membership each year. Leave the box checked if you would like MARSP to automatically renew your membership going forward. Uncheck the box if you do not wish to automatically renew your membership. Click "Next" to continue.

5. Donation option

You now have the option to donate to MARSP and MARSP Foundation funds. The default donation amount is \$5, but you can type in an alternate amount. Click "Add" to include the donation amount in your final total. Click "Next" to continue.

6. Review selections and cart

Review your membership and donation selections. If everything is correct, click "Add to Cart." Check the subtotal. Click "Checkout" if everything looks correct.

7. Payment method and billing address

Select the circle next to "New Payment Method" so that it turns green. Enter your payment information. Then select the circle next to your billing address OR add a new billing address. Once your payment method and billing address are complete, the "Checkout" button on the bottom right will change from gray to blue. Click "Checkout" to continue.

8. Processing payment

A pop-up will confirm that your order is processing. Once complete, close the window. You'll receive order confirmation via email.
